Directions

Complete directions on product label
Lawn and Turf: Dilute 2 quarts in 200 gallons of water to treat one acre.
Hard to kill weeds: Use 1 gallon in 100 gallons of water per acre.
Woody plants: Mix 8 ounces in 1 gallon water and drench plant. Repeat application in four weeks if necessary.
To Kill Stumps: Mix 1 pint in 1-quart kerosene or diesel oil.

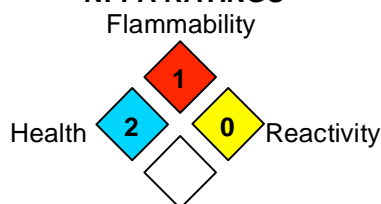
Safety
