



## DANGER

### DIRECTIONS

Dilute in warm or hot water for best performance. Spray, brush or mop on and allow cleaner to penetrate and loosen deposits. Flush away with a clean water rinse.

To remove difficult or hard deposits, allow the solution to saturate the surface for 5 minutes, then rub gently with steel wool and rinse.

**Use Dilution A FOR:** Removing wax on asphalt tile, vinyl floors, terrazzo, concrete, and all other hard and resilient floors.

**Use Dilution B FOR:** Ovens, fryers and grills, kitchen hoods, and air filters.
