DIRECTIONS

TO FORMULATE INTO A HIGH COUNT BACTERIAL DIGESTANT: Dilute 5 gallons (19.1 liters) of this concentrate with 50 gallons (189 liters) of unsoftened water to make 55 gallons (208 liters) of ready to use product. The finished product will possess a bacterial content of 80,000,000 colonies per milliliter minimum. Blend well and package immediately.

TO USE DILUTED PRODUCT:

TO CONTROL SURFACE ODORS: Dilute 1:1 with tap water. Spray a heavy mist to wet the surface and allow to eliminate odors naturally.

CARPETS AND UPHOLSTERY: Remove as much soil as possible. Dilute the diluted product 1:1 with tap water. Spray to wet fibers thoroughly. Brush liquid into the material. Lay a damp towel over the area to keep it moist for at least 24 hours. Severe odors may require a daily treatment for up to 10 days.

USE IN PLUMBING: Treat drains with dosages varying from 2 to 8 ounces(60 to 240 mls.) per week to keep them free-flowing and fresh smelling.

NOTE: Do not flush with hot water or use bleach or disinfectant within 24 hours of product addition.
