### **DIRECTIONS FOR USE**

GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its label.

This product is used to control algae, bacteria and fungi in recirculating commercial and industrial water cooling towers. Fior to its use, systems must be cleaned to remove algae growth, microbiological slime and other deposits.

An initial's up addition of 6.13 to 19.32 fluid ounces per 1000 gallons of water to provide a concentration of 4. to 12.5 parts per million based on the total weight of water in the system. Repeat initial dosage until control is evident.

Stosect entiting additions of 1.53 to 15.32 fluid ounces per 1000 gallons of water (12 to 120 parts per million) must be employed every 2 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions must be made in the sump of water cooling towers.

### STORAGE AND DISPOSAL

Do Not Contaminate Water, Food, or Feed By Storage or Disposal.

Storage: Store in a dry place no lower in temperature than 50°F or higher than 120°F.
