AUTOMATIC POWDER

DESCRIPTION: This machine dishwashing powder contains a powerful blend of cleaning agents to cut through heavy food build-up, dried-on deposits and stubborn grease and oil. Special sequestering agents assure thorough cleaning of glass, porcelain, metal, plastic and earthenware, even in hard water. 1.5% CHLORINE cleans tough protein soil and removes stubborn stains like coffee, from all surfaces.

DIRECTIONS: Rack dishes and pre-rinse. Use 1/3 ounce of product per 1 gallon of water in the wash tank for continuous feed equipment. Powder feeding equipment should be kept charged with detergent. If there is no detergent feeding equipment, add 1 heaping tablespoon of detergent per rack of dishes. Hard water areas may require additional amounts of detergent. Rinse with hot water (180°F or above). Not intended for hand washing of dishes.

This product may also be used as a heavy duty detergent for cleaning floors, walls, utensils and equipment in food processing plants. Use 1/4 to 1/2 cup per 1 gallon of warm or hot water. Remove or carefully protect food products and packaging materials. Rinse all surfaces thoroughly with potable water.
