It quickly flushes out beverage residues and other deposits to leave the lines perfectly clean and maintains the natural aroma and true flavor of the beverages in dispensing systems. Regular cleaning of beer lines and faucets assures that the beer tastes and smells as appetizing and fresh as the day it was brewed.

DIRECTIONS: The amount of cleaning solution required is determined by the length of the beer or wine lines. For short lines, 1 quart is sufficient. Long lines require 2 to 3 quarts. Use 1/2 to 1 ounce of BEER LINE CLEANER per quart of warm or cold water. Pump the cleaning solution through the lines and rinse thoroughly with cold water or beer.

To clean faucets, disassemble and soak in cleaning solution, then rinse faucet parts with clean water before reassembling.
